

Power of Attorney

Know all men by these presents that _____ (Taxpayer) in the County of _____, State of _____, do hereby make, constitute, appoint, and authorize the representative(s) listed below as my true and lawful Attorney-In-Fact to appear for me and represent me before the **Board of Equalization and Review in the County of New Hanover**, in connection with any matter involving the **ad valorem taxation** of the property described below. I grant full power and authority to appeal the property tax value assigned by the County to the described property, and the power to make full and complete settlement or other disposition of the matter. I hereby authorize New Hanover County to disclose to my Attorney-In-Fact all information used by the County in connection with the listing, appraisal, or assessment of the said property, including specifically information of a confidential nature.

In addition, my Attorney-In-Fact is authorized to file a notice of appeal to the North Carolina Property Tax Commission in the event of an adverse decision by the New Hanover County Board of Equalization and Review and to represent me in the preliminary investigation of the appeal by the Commission.

I UNDERSTAND THAT THE PROEPRTY TAX VALUE OF ANY PROPERTY APPEALED MAY BE LOWERED, LEFT UNCHANGED, OR INCREASED AS A RESULT OF THE APPEAL.

I also understand that my Attorney-In-Fact, unless he is an attorney at law authorized to practice in the State of North Carolina, will not be allowed to represent me at any hearing to be held before the North Carolina Property Tax Commission, for such representation would constitute the unauthorized practice of law.
